BNM top bond issuer in Q1

MARKET LEADERS: Hong Leong Financial Group is top corporate bond issuer and CIMB Investment Bank is top lead arranger for two quarters

BANK Negara Malaysia (BNM) issued RM67 billion bonds for the first quarter of 2012, making it the top bond issuer, Bond Pricing Agency Malaysia (BPA) said.

BPA, in its latest bond market rankings, said the overall top traded bonds during the periods were those issued by the Malaysian government, valued at RM227.7 billion and RM130.2 billion respectively.

According to BPA, the top traded sukuk, or

Islamic bonds, were those issued by BNM Sukuk Bhd at RM77.20 billion. It marked a more-than-200 per cent increase versus the last guarter of 2011.

Hong Leong Financial Group Bhd remained the top corporate bond issuer with issues worth RM1.32 billion, while Public Bank Bhd's notes were the top traded corporate bonds at RM1.73 billion.

CIMB Investment Bank Bhd, which was the top lead arranger during both the periods, saw a jump in issuance value from RM8.30 billion in the last quarter to RM35.17 billion during the first quarter of 2012.

Maybank Investment Bank Bhd was top lead arranger (by issuance) with 89 issues.
